Terms & Conditions

1. Registration will be done on "first come first serve" basis.
2. All mission members would be required to arrive at Shanghai latest by June 16, 2019 (evening)
3. Shanghai Airport-hotel-airport & Beijing Airport-hotel-airport transfer charges would have to be borne by the Mission members themselves
4. Mission members will buy air tickets (India – Shanghai – Beijing – India) on their own.
5. CII would negotiate with a centrally located hotel for the best tariff possible. All the Mission members would be required to stay at the same hotel for smoother coordination. However, board and lodging expenses would have to be settled directly by the Mission members at the hotel.
6. Any admission charges would be payable by the members themselves
7. A coach would be arranged by CII each working day for all the local travels and visits to various places during the Mission (June 17 - 21 2019). The delegates would be required to pay for their share of local transport charges.
8. Mission members are requested to attend all the meetings / visits as per the final program of the mission and adhere to timing of all the meetings / visits in China.
9. The suggested dress code is formal, unless mentioned otherwise
10. CII will not be held responsible in case of any last-minute change / cancellations of meetings / visits during the mission.
11. CII will assist the Mission Members to get China visa by providing invitation letters from China and from CII. CII will NOT be responsible, in case Embassy of the People's Republic of China refuses to issue visa, for any reason
